About the Mizzou Law Veterans Clinic

Established in 2014, the Clinic represents veterans and their families regarding VA disability benefits and discharge upgrades. Since its inception, the Clinic has secured more than \$20 million in VA disability compensation for its clients as well as numerous discharge upgrades.

Law students can participate in the Clinic as part of their law school curriculum where they get hands-on experience working with real clients prior to graduating. The Clinic offers various types of courses including Veterans Clinic, Advanced Veterans Clinic, Veterans Law, Military Law, and Law of War.

The Clinic also has several programs aimed at specific efforts. These programs include initiative regarding amicus briefing, rural veteran outreach, veteran homelessness, military lawyer support, and a partnership between the Veterans Clinic and Mizzou's medical school.

The Clinic operates on funding from the Missouri State Legislature, grants from the federal government, and private donations. Private donations remain a substantial portion of the Clinic's operating budget.

The Annual Symposium

Each year since its inception in 2014, the Veterans Clinic has held a Symposium on important topics impacting the veteran community. This year's Symposium centers on the topic of veteran homelessness. Previous topics include burn pits, traumatic brain injuries, and more.

The session will review the legal framework governing discharge upgrades and provide insights into navigating the application process to secure improved outcomes for homeless veterans.
Collaborative Advocacy: Bridging Legal Expertise and Pro-bono Service	This brief presentation will highlight the benefits of working on cases on a pro-bono basis.
A Discussion: City of Grants Pass & Criminalization of Homelessness	This discussion examines the Supreme Court's decision in City of Grants Pass v. Johnson and how it will affect unhoused veterans. Attendees will gain a deeper understanding of the case and opportunities for advocacy.
Veterans Community Project: No One Left Behind	Bryan Meyer will share his transformative insights and experiences working with homeless veterans. His keynote address will focus on innovative strategies and programs that have proven effective in addressing veteran homelessness.

Dana Montalto	Dana Montalto is a Lecturer-on-Law and Associate Director of the Veterans Legal Clinic at Harvard Law School's Legal Services Center. She represents veterans with less-than-honorable discharges seeking upgrades and benefits and founded the Veterans Justice Pro Bono Partnership to connect them with volunteer attorneys. Dana is the lead author of several major reports on VA access and discharge policy and has published scholarship on veterans law. She earned her B.A. from Wellesley College and J.D. from Yale Law School, where she was active in veterans and refugee advocacy. She joined the Legal Services Center in 2014 after clerking for Judge F. Dennis Saylor IV.	
Hugh McClean	Hugh McClean is an Associate Professor and Director of the Bob Parsons Veterans Advocacy Clinic, which he founded in 2014. He supervises student attorneys in representing veterans in litigation and policy work. A former U.S. Air Force JAG from 2003 to 2014, McClean served as a prosecutor, defense attorney, and special counsel at the Pentagon, and taught at the U.S. Air Force Academy, where he earned multiple teaching and service awards. Before his military service, he was a public defender in Ohio. McClean holds an LL.M. from The George Washington University Law School and is a member of the Ohio and Maryland bars.	
Brent Filbert	Brent Filbert is Director of The Veterans Clinic at the University of Missouri School of Law, where he also teaches Military Law and Law of Armed Conflict. He brings over 35 years of legal experience in both military and private practice, including roles as a Navy appellate judge, prosecutor, defense counsel, and Special Assistant U.S. Attorney. He previously led military law efforts at the Veteran Advocacy Project and worked as a litigation partner at Shook, Hardy & Bacon. A Mizzou alum, he earned his J.D. with distinction from UMKC, an LL.M. in Trial Advocacy from Temple, and is a distinguished graduate of the Naval War College. He joined the clinic to train students through impactful work serving veterans.	
Gregg Maxon	Brigadier General Richard Gregg Maxon retired on July 1, 2008, after a distinguished career in military and state service, most recently as Director of the Arizona Department of Veterans' Services. He began his service in 1972 as an Army linguist, later earning degrees in law and business from Arizona State University. Rejoining active duty in 1980 as a Navy Judge Advocate, he transitioned to the Arizona Army National Guard in 1984, eventually becoming Assistant Adjutant General and earning the rank of Brigadier General in 2000. A licensed attorney, Maxon has served in various judicial roles, including Judge on the Arizona Court of Military Appeals and presiding over the East Valley Regional Veterans Treatment Court. He worked in the Veterans Clinic from spring 2022 - 2024.	
Judge Cotton Walker	Judge Cotton Walker serves as the Division 3 Circuit Judge for Cole County in Missouri's 19th Judicial Circuit. Judge Walker has over three decades of legal experience, including 27 years in privates practice and over two decades of being a municipal judge. A graduate of Indiana University and University of Missouri school of Law, he is a former municipal prosecutor and past president of the Missouri Municipal and Associate Circuit Judges Association. He has served on numerous statewide judicial committees and currently oversees Cole County's Treatment Courts. Judge Walker is also active in his community through organizations like Habit for Humanity and Project Homeless

Nishimoto is the Executive Director of the UCLA Veterans Legal Clinic, which provides legal assistance to veterans, caregivers, and families who access services at the U.S. Department of Veterans Affairs West Los Angeles campus. Her primary areas of practice are issues related to homelessness, housing justice, and access to government benefits. Nishimoto earned her B.A. from Amherst College and her J.D. cum laude from the University of Michigan School of Law where she was a student attorney in the Civil-Criminal Litigation Clinic and Pediatric Advocacy Initiative and Executive Editor for the University of Michigan Journal of Law Reform.
	Andy Rogers	Andy is the Show-Me Home Program Coordinator at the Mizzou Law Veterans Clinic, where she helps provide services to eligible veterans facing or at risk of homelessness through funding from the U.S. Department of Veterans Affairs Veterans Justice Program. A Licensed Clinical Social Worker since 2005, she holds a master's degree from the University of Missouri School of Social Work and brings over a decade of experience from her work at the Harry S. Truman Memorial Veterans Hospital. Her background in clinical social work and veteran care aligns closely with the goals of the Veterans Justice Program.
	Yelena Duterte	Yelena Duterte joined UIC School of Law in 2019 as an Assistant Professor of Law and the Director of the Veterans Legal Clinic. Prior to joining UIC, Professor Duterte taught and directed the Veterans Legal Clinic at Syracuse University College of Law. In clinic practice, Duterte is a past-president and active member of the National Law School Veterans Clinic Consortium (NLSVCC). She received her law degree from University of Illinois Chicago School of Law and her B.A. in Economics and Political Science from University of Illinois Chicago.
